Certification through the Ohio Peace Officers Training Commission as a peace officer is necessary before applying for this volunteer position. Reserve Deputy Applicants must complete the same selection process as full-time employees.

Reserve Deputy Applicants must be at least 21 years of age and possess a high school diploma or equivalent. Reserve Deputies must possess a valid State of Ohio driver's license. This is an unpaid sworn position. Reserve Deputies must complete a requisite number of volunteer service hours each month. Reserve Deputy Applicants should call if they desire additional information.
